
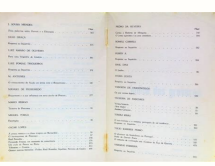

#### A Estrada: Una pequeña historia

El nombre de *La Estrada* procede de la voz en latín *strata*, con el significado de *tierra pisada, por donde se anda, camino*. De hecho, dos caminos se cruzaban en la plaza principal: de sur a norte subía un camino desde *Tierra de Montes, Orense y Portugal*, por donde los *arrieros y peregrinos* iban a *Santiago de Compostela*; y del este a oeste, desde tierras del *Deza, Trásdeza* y del interior de Galicia, por donde *arrieros* y, más tarde, *carrianas* se dirigían a la costa.

#### Etimología



La *jurisdicción de Tabeirós* tiene su origen en tiempos del rey *suevo Miro* en el *siglo VI*, y aparece citada en el *Cronicon Iriense* como perteneciente a la *diócesis de Iria*. En el *siglo XII*, el arzobispo de Santiago *Gelmírez* y el rey *Afonso VII de Castilla* intercambiaron entre sí la tierra de Tabeirós, *Tabeirilos* y el castro de Faro, pasando la primera a ser posesión de la mitra compostelana. Esta jurisdicción abarcaba todo el actual Ayuntamiento de La Estrada, con excepción de las parroquias de Bea, hasta *1840*, año en el que se creó el Ayuntamiento y el *partido judicial* de La Estrada (hoy capital de partido judicial que comprende los ayuntamientos de La Estrada, *Ferreira* y *Cerdedo*).

Tres años antes, por culpa de los enfrentamientos entre *absolutistas* y *liberales*, se trasladó la casa consistorial de Tabeirós desde *Cereijo* al lugar de La Estrada, formado únicamente por 4 casas en un cruce de caminos entre las parroquias de *Figueroa, Quzande* y *Guimarey*.

#### Historia

Desde el *siglo XII*, estas tierras que hoy comprenden el municipio de La Estrada estaban políticamente divididas en "cotos" y jurisdicciones, en
